Mr. Mr. Chonlatit Surasawadi, the Director General of the Royal Forest Department is the chairman of the meeting on Thai-EU FLEGT VPA under the topic of The Ad-Hoc Working Group Meeting of Thai-EU FLEGT VPA on TLAS Description No.1/2017.

The purposes of the meeting

- 1. To understand the legality of the Timber Legality Assurance System (TLAS)
- 2. To present and develop the TLAS system
- 3. To prepare for FLEGT VPA negotiations between Thailand and the EU

The expected results

- 1. The working group are understand basic of the TLAS
- 2. The diagram is drafted and guidelined for the development of Thailand's TLAS system.

Agenda item 1: Notifications

Mr.Chonlatit Surasawadi, the Director General of the Royal Forest Department informed the meeting that The Royal Forest Department is willing and prepared to support the VPA FLEGT Program to achieve the goals in a given period.

Mr. Banjong Wongsrisoontorn, Director of Division ofForestry Certification Office and Director of TEFSO reported that the accordance with The Ad-Hoc Working Group Meeting on Supply Chain Control No. 1/2016 on 30th August 2016 consists of revising the detailed on the diagram of Supply Chain Control which Thai – EU FLEGT Secretariat Office done editing.

Agenda item 4: Notifications

Dr. Alexander Hinrichs , Asian FLEGT Consultant from the European Forestry Institute (EFI) presented basic information about the elements of preparation Control of imported timber (look at the attachment 1) and answered questions about the matter. The attendees were focus on scrutiny and timber import process. The data were analyzed as follow

Elements of TLAS is divided into 5 parts

1. Legality Definition (LD)

Legality definition is an important appendix in the Voluntary Partnership Agreement (VPA). The compilation of the appendix is not just the incorporation the existing law into the appendix. But it must be the result of stakeholder dialogue to gain acceptance from all parties.

2. Supply Chain Control: SCC

Supply Chain Control is one of the elements in the Timber Legality Assurance System. It will be proven from land type, processing, transportation, and trade process to confirm the legality of wood and their products.

3. Verification

The Verification must know roles of who is an inspector, where and how to inspect. The word "who" could be government agencies, private or civil society sector. For instance, Indonesia gives civil society organization a chance to participate in the verification process.

In the past, Thailand has Mini-Field Test once to test whether the verification identified in the Legality Definition can be effectively implemented. The next field test will begin in May. Experts will come to test and improve the verification process to be most effective.

4. FLEGT Licensing Procedure: LP

EU rules EUTR to prevent illegal logging into EU. So, if any country has FLEGT license it will be possible to bring the timber into the European Union without having to conduct a validation. For FLEGT Licensing Procedure, There must be a specific organization or agency to do this role. (Example of FLEGT License of Indonesia is in the attachment 1)

5. Independent Audit: IA

Agencies that play a role in independent audits must not be stakeholder and it must be a specializes in monitoring systems. It must be investigated and assessed whether the monitoring system is as assigned. Then Submission of the results to the two committees which consists of Partner and EU (Joint Implementation Committee: JIC) to continue debugging. The independent Audit requires TOR writing to assign roles and must be mutually accepted by both parties.

Example of TLAS legal guarantee system of Indonesia and Liberia (see attachment 1)

The development of TLAS in each country may be different. But it must consists of the 5 elements which mentioned above initially. Dr. Alexander Hinrichs exemplifies the legal guarantee system of Indonesia and Liberia in the presentation. The example in the presentation shows that the system in Thailand is similar to Liberia because Liberia also has a verification agency that is

also appointed under the Forest Department. But in Indonesia, they uses a private company and /or civil society serves as such verification.

Timber exportation control (see attachment 1)

The European Union consists of 28 member countries. It is a commercial market where timber products are imported into the EU market. It is divided into 2 groups as 1) wood from VPA member country and 2) wood from non-VPA member country. The non-VPA member country requires Due Diligence System (DDS) to confirm the legality of the source.

The Due Diligence System consists of 3 elements

- 1. Information: Show information related to wood imports.
- 2. Risk Assessment: Evaluation based on credibility of country of origin and type of timber.
- 3. Risk Mitigation: If it is found that wood products are at risk, it is necessary to obtain additional evidence to confirm the legality.

Because Thailand is a country that imports wood from neighboring countries and transform it into various wood products to export, so we can use the document review system or C/O to reduce the risk to be accepted.

Mr.Chonlatit Surasawadi, the Director General of the Royal Forest Department expressed appreciation and appreciated that this meeting was very useful to start developing other timber processes especially the process of exporting timber products to the European Union. Thailand has focused on importing and exporting wood for long time. It is well known that some Thai laws are interfere with the operation and monitoring. To reduce the interfere, the government sector have to adjust too. The Royal Forest Department as a stakeholder, will consider to reduce the risk of timber sources and control their imports. It is expected that the year 2017 will be able to solve the problem to a certain extent and the electronic systems will be used to develop processes for more modern.

Agenda item 5: Notifications

Mr. Banjong Wongsrisoontorn, Director of Division of Forestry Certification Office and Director of TEFSO of RFD asked the stakeholders to divided into 2 groups to consider 2 topics, as follow

Group 1: To discuss on importing controal of Thailand.

Group 2: To discuss on the Independent Audit Context of Thailand.

Consulting Summary of 2 groups

Group 1: To discuss on importing controll of Thailand.

MS. Rungnapa Wattanavichian, Researcher of DARC, a representative of Group 1 reported the result of the topic as follow

Group 1 is interested in timber import method of Vietnam. So they offer that timber product which has FLEGT, CITES, FSC and other certification which is internationally recognized could be imported automatically to Thailand. In the case of timber without acknowledge certification could be used the Due Diligence System or DDS to prove the legality.

However, if there is any question about the information provided in the document, Thailand is able to request additional documents to reduce the risk. And use the screen document method instead of divided the documents by the risk level of species and location like Vietnam. In the future, Thailand has to establish the law to enforce because Thailand exports timber products to many countries around the world. The import standard should be the same standard for easy conducting.

Dr. Alexander Hinrichs, Asia Regional FLEGT Consultant From the EFI provided feedback on groupings of certificates endorsed by the government and private sector. For instance, PEFC FSC certified by private sector should be under due diligence system.

Group 2 To discuss on the Independent Audit Context of Thailand.

Mrs. Arunwan Petchsang, manager of Thai Hevea Wood Association, the representative of Group 2 reported the result of the discussion on the Independent Audit Context of Thailand as follow

Group 2 presented TLAS by offering the idea to appoint the National Platform Committee between the stakeholders and secretariat office which has the roles to provide information, coordinate, respond complains and organize the meeting to summarize and improve operations every year. Any institute who wants to be Independent Audit must not be the VPA stakeholder. And those institute have to know how to verify entrepreneurs and the TOR should be set up to determine the role of the institute. Group 2 presented the institutes which are possible to perform an independent audit as follow

- 1. Thai-forest certification network
- 2. Private sector
- 3. Educational institution
- 4. Special purpose entity
- 5. Thai industrial standard institute

For Inspection agency, Group 2 offered the electronic system to investigate. And the Royal Forest Department may empower the authority concerns for investigation.

Resolution be informed.

Agenda item 6: other matter

MS. Rungnapa Wattanavichian, Researcher of DARC presented the introduction of the project on the guideline of unlock unregulated species on private land which is the one of gap/issue paper. The project will use industrial standard 14061 and Chain of Custody to test the big and small operators that consider to valued and compliance to FLEGT.

According to the project, she would like to invite the relevant working groups to attend the meeting and discuss about the project.

Next step:

 TEFSO gathers information from the meeting for reference on working with LD field-test consultants that have a scope on suggestion and developing TLAS structure.
